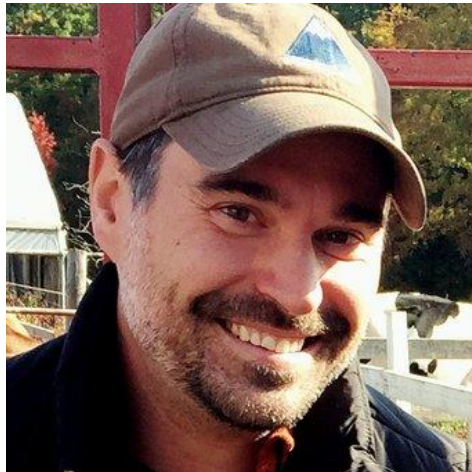
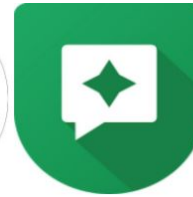

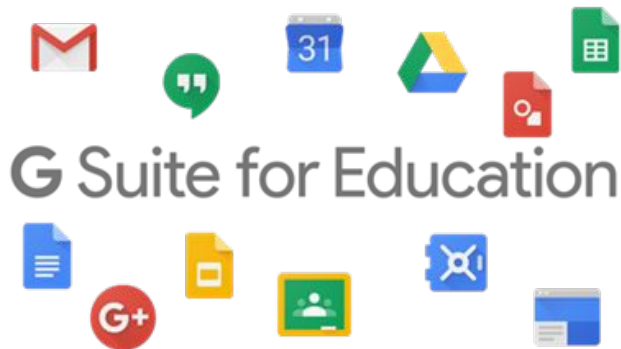
York's Plan

G Suite

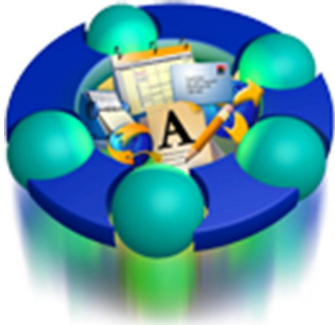
- Move everyone to a streamlined system for communication, collaboration, creativity and critical thinking. (We were using a legacy local email server and a combination of Microsoft Office and Apple iWorks tools for all work and communication.)
- Our mission was to adopt a platform that could work on any device, easy to understand from the user experience, provide for privacy of files and data, and still work within our budget.
- Easily migrate existing email and data files to a new solution would be a huge bonus!
- Purchase devices, but also allow for personal devices to be used in accordance with our rollout
- G Suite for Edu was, and still is, the best solution out there for our needs.

York's Plan

- Created a single Google for Edu domain.
- Created Organizational Units for each school and grade level for global and granular level settings and permissions. (i.e. No GMail for Elementary Kids)
- Provided all staff and students with Google Accounts, but kept a dual delivery email system in place for 6 months. This worked for us, but does not mean this would work for every school district, or business.
- Purchased chromebooks for shared spaces and carts to pilot these devices in education.

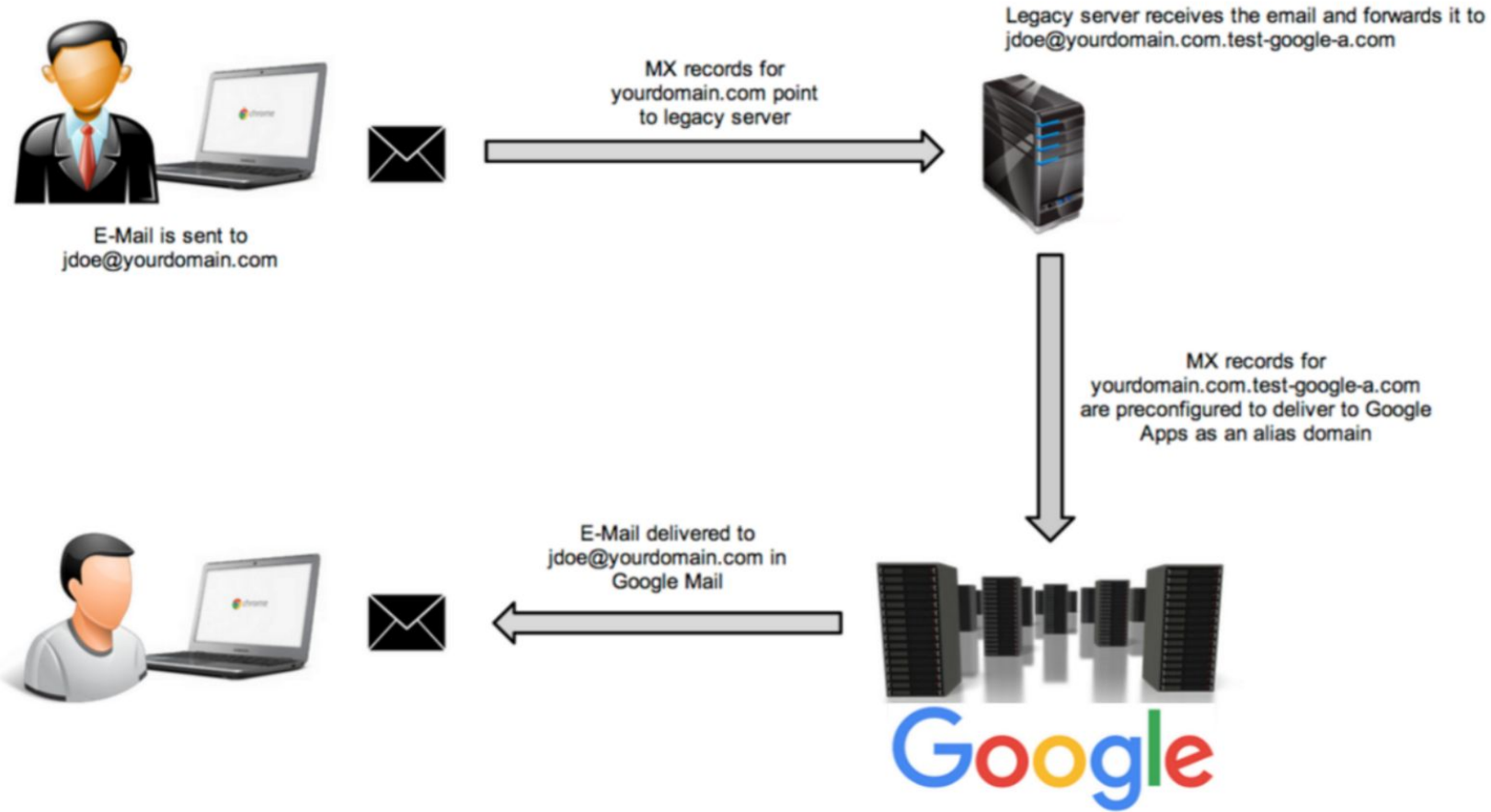

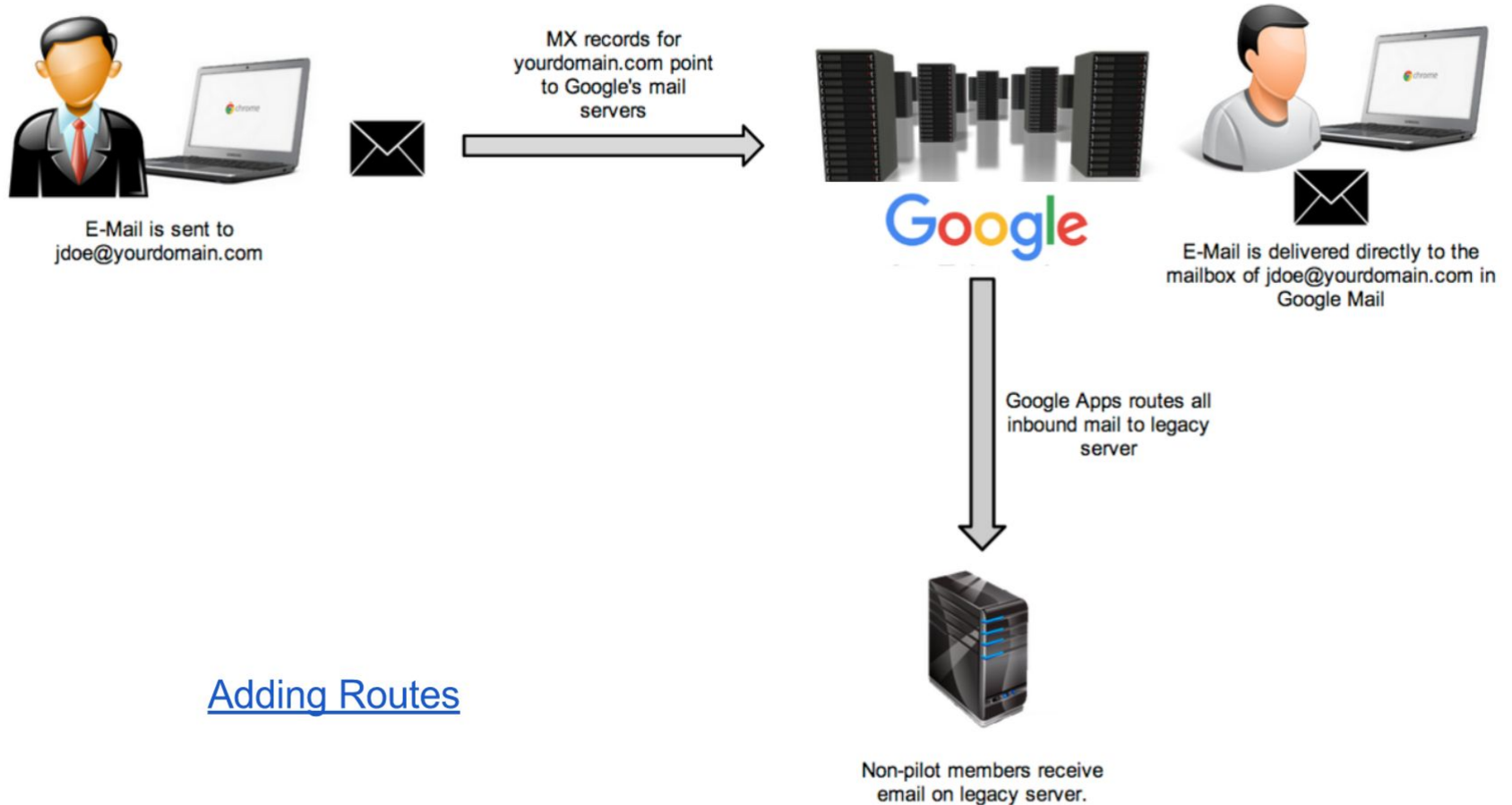

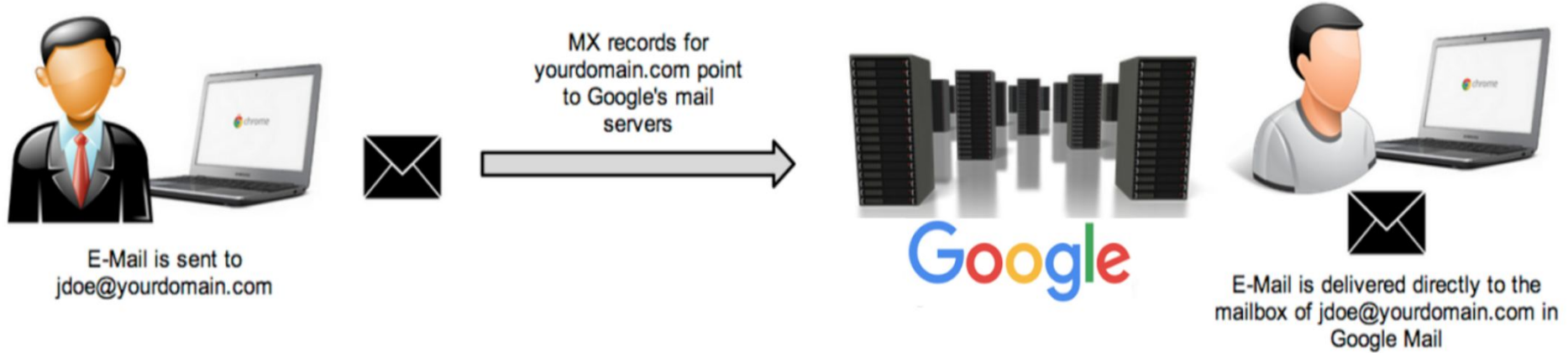
Dual Delivery - Legacy Server Primary

Team Drive



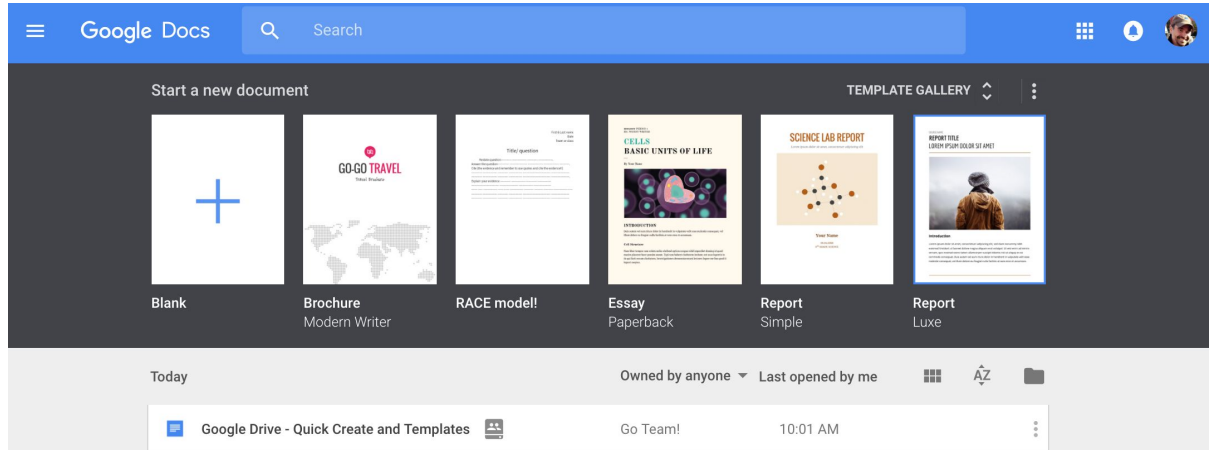

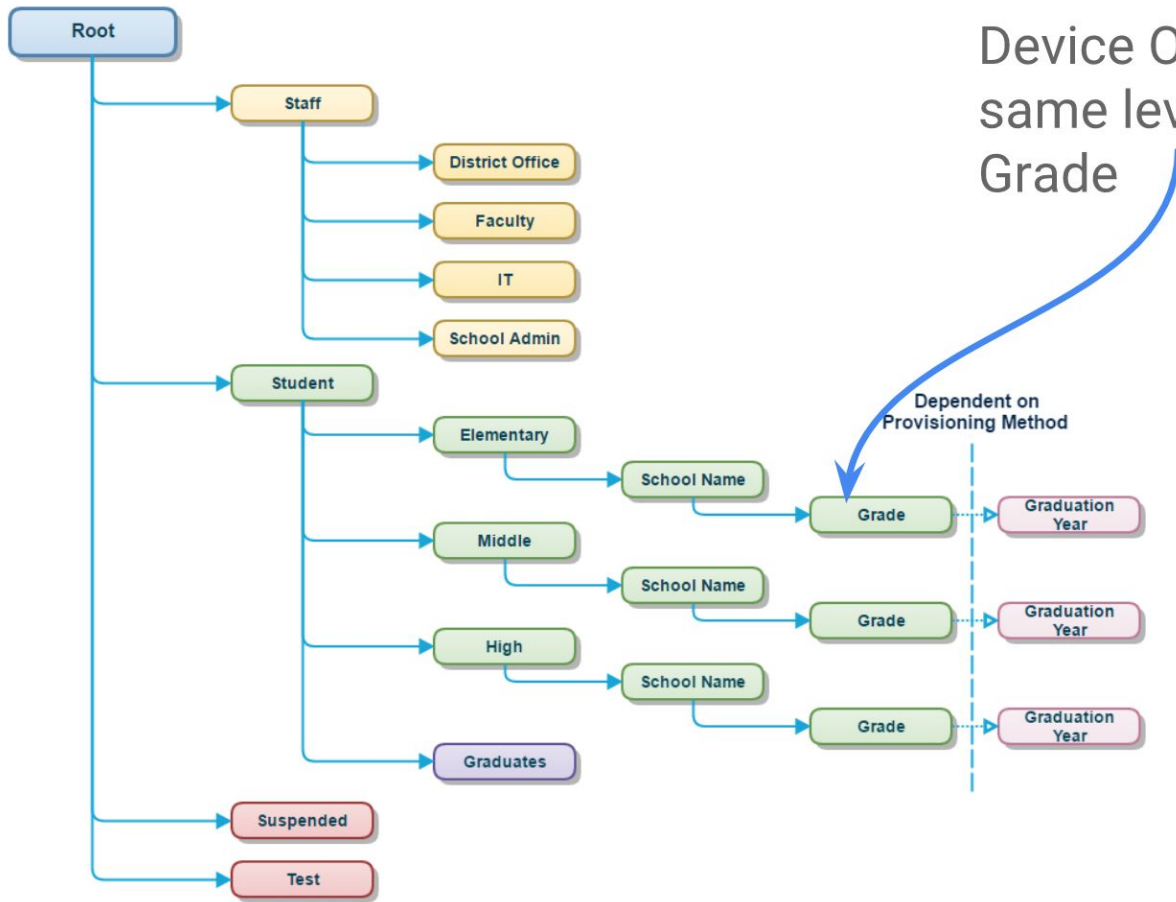

Importance of an OU Structure

Gives you the Ability to...

...set device settings per OU (i.e. allow guest mode on certain devices for sign in purposes)

...set user settings and permissions per OU (i.e. allow incognito mode for staff, but not for students)

...to deploy apps, extensions and startup pages per OU (i.e. including kiosk apps for testing or single function)

...test new settings before rollout to the larger group (i.e. test Google's latest update like Team Drives with a select few before everyone has the ability to create these folders)

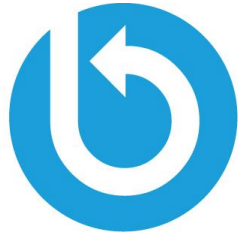
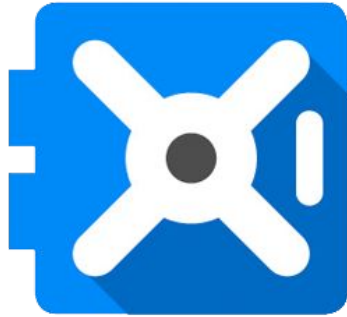

- We primarily use this tool to search matters for litigation investigations or FOAA requests.

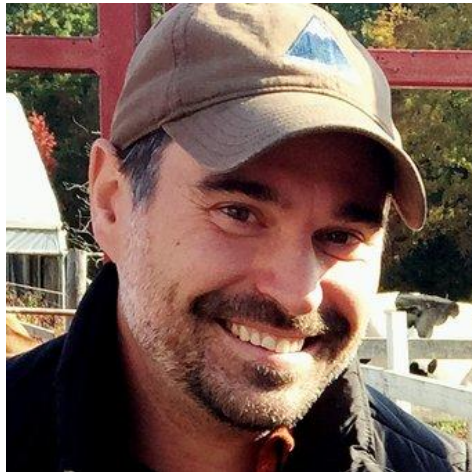
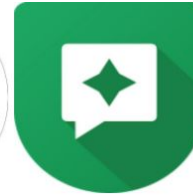
