**Job Summary:**

Travel Wellness Nurse Assignment to cover immediate 6 week assignment Clinton, MA Saturday through Wednesday day shift. Must be RN licenses in MA.

The Travel Wellness Nurse is responsible for assisting the Resident Care Director with the overall implementation, delivery and coordination of Resident Care services at the Community level. Will also assist in monitoring the medication management program and other regulatory compliance as required per governing state regulation. This position reports to the Vice President of Resident Services.

**Duties and Responsibilities:**

The following essential functions are the fundamental job duties of the position to be completed with or without appropriate reasonable accommodation.

- Assist in supervising the medication program and assist residents with self-administration of their medication.
- Maintain positive relations with residents, families and physicians.
- Report any significant incidents and/or changes in the residents needs to the Executive Director/Resident Care Director.
- Assist Resident Care Director in the completion of resident assessments and services plans.
- Assist in the training of Resident Care staff and in orientation of new staff.
- Attend and participate in scheduled in-service programs, training programs and staff meetings.
- Assist with supporting and leading Resident Care Assistants with clinical questions.
- May perform other duties as assigned.

**Minimum Qualifications:**

- Registered Nurse/Licensed Practical Nurse/Licensed Vocational Nurse with a current compact license in good standing and willingness to become licensed in other states as required.
- Certification or licensed per state guidelines.
