Price Transparency Evaluation and Management

If you are a <u>new patient</u> to the practice, our provider will charge the visit as a new-patient encounter.

A new patient is defined by the American Medical Association as a patient that has not seen a provider in a group practice in 3 years.

If you are evaluated for an injury, our provider will request an X-ray (radiology film) to be taken of your injury. Please see the radiology prices in the *Radiology* section.

A <u>**new-patient**</u> visit charge varies based on the complexity of the medical injury or illness the provider is evaluating.

## Consultation

## **Post-Operative Period**

The American Medical Association (AMA) defines the post-operative period as 90 days from the date of the surgery (in the case of major operations). This is called a *global billing period*. Within that period, OrthoAlaska LLC will not charge for a face-to-face or telehealth postoperative visit with the provider to discuss your healing and results. Per the AMA, a provider is allowed to charge after surgery for images (X-rays, CTs, MRIs, or other imaging deemed necessary by your provider), cast material and application, injection, or medication, as well as any type of brace, boot, etc., that is defined as Durable Medical Equipment (DME). Complications related to surgery will usually incur a new charge.

Minor surgical procedures have a 10-day global period.

Seeing a provider for any injury/illness unrelated to the original procedure will incur a cost for an evaluation and management charge and the cost of any necessary X-rays or treatments.
