Fees and Charges

FCIA Training Academy Ltd (FCIATA) may be entitled to charge fees to the students undertaking training under a Government Funded Training Contract and under fee for service arrangement.

Unless specified otherwise, course fees include the cost of all compulsory training and assessment materials, including textbooks. Course fees also include the issuance of one (1) copy of the relevant certificate to a student upon completion or withdrawal from their course. This includes Qualification Testamurs, Statement of Attainment, Record of Results and Statement of Attendance, and any other as required by government or other accrediting bodies.

FCIATA reserves the right to adjust fees without notice, where state governments change the scheduled hourly rate any time during the term of the contract within a calendar year.

Funded students

Student Fees - ACT

For students funded by Skills Canberra as apprentices, FCIATA charges \$4,000 in total as student fees for the duration of the apprenticeship, i.e., 4 years. The fees are charged annually (\$1,000 per year) as per below:

Fee for Service students
